#### 19. Lr1 State's Follow sets and reducing lookahead sets.

#### Notes on Follow set expressions:

1) The "follow set" for rule uses its literal name and tags its grammar rule rank number as a superscript. Due to space limitations, part of the follow set information uses the rule's literal name while the follow set expressions refers to the rule's rank number. This < rule name, rule rank number > tupple allows you the reader to decifer the expressions. Transitions are represented by  $S_x R_z$  whereby S is the LR1 state identified by its "x" subscript where other transient calculations occur within the LR1 state network. R indicates the follow set rule with the subscript "z" as its grammar rank number that contributes to the follow set.

The  $\nearrow^x$  symbol indicates that a merge into state "x" has taken place. That is, the reduced subrule that depends on this follow set finds its follow set in 2 places: its birthing state that generated the sequence up to the merged into state, and the birthing state that generated the "merged into" state. So the rule's "follow set" calculation must also continue its calculation within the birth state generating the "x merged into" state.
